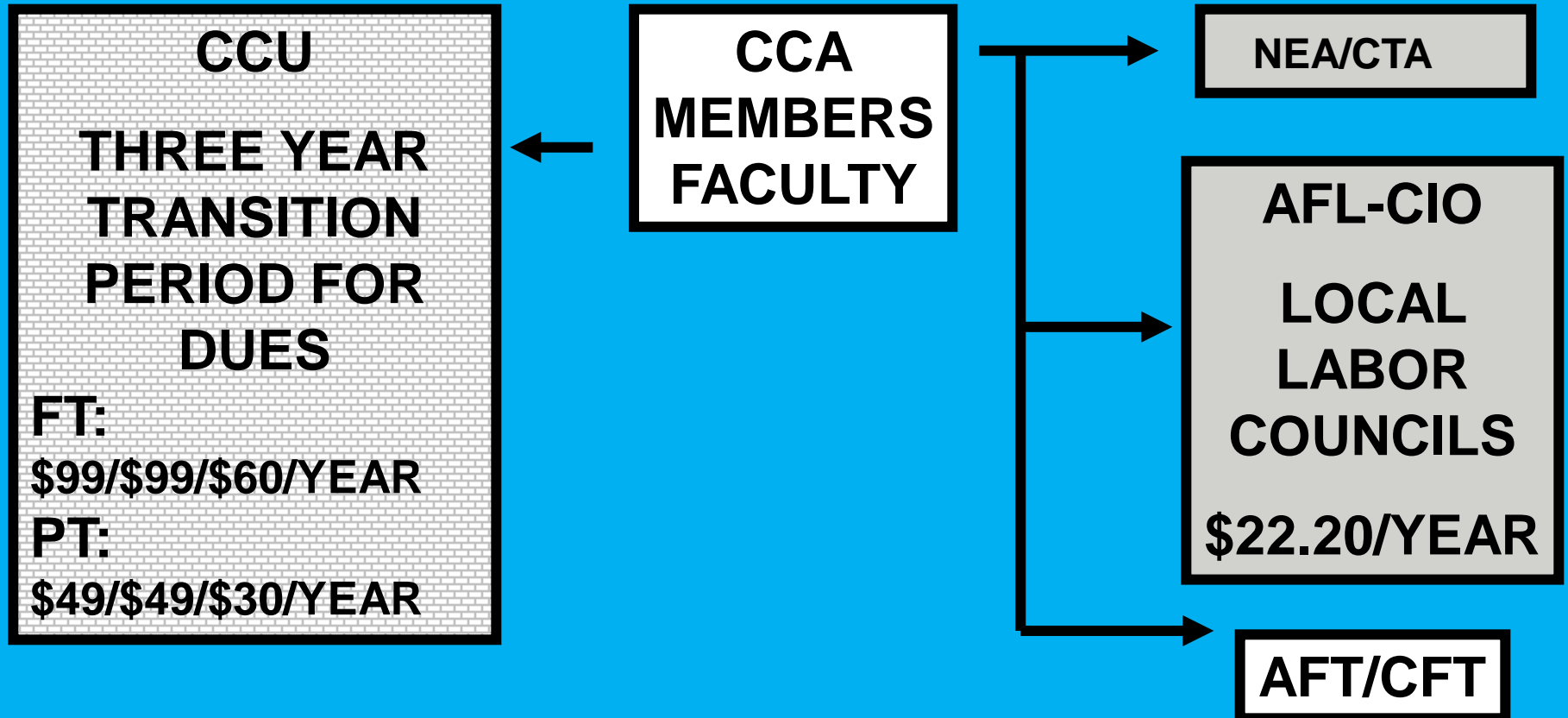

# **COMMUNITY COLLEGES UNITED SCHEDULED MEETINGS**

**All meetings are open to CCU members.**

## **DELEGATE ASSEMBLY**

**Delegates elected by each local one per 100 members or fraction thereof.**

**Each delegate will have expenses reimbursed by the CCU. (DOUBLE OCCUPANCY)**

**Elects Officers and Members of the Board of Directors.**

**Every local receives at least one delegate.**

**One meeting per year.**

## **OFFICERS**

**Shall meet at least 4 times per year, more often as necessary, to coordinate the activities of the committees and help plan the meetings for the General Assembly, Board of Directors, and Council of Presidents.**



# **COMMUNITY COLLEGES UNITED SCHEDULED MEETINGS**

## **BOARD OF DIRECTORS**

**Shall meet 4 times per year, which includes the Officers, special meetings may be called. Directors shall conduct the business of CCU between meetings of the Delegate Assembly. The Board shall be responsible for the employment of all professional and clerical CCU staff, released-time members, and members paid stipends for specific services rendered to CCU.**

## **COUNCIL OF PRESIDENTS**

**Shall be composed of sitting Presidents and the CCU's Officers and will meet at least (2) times per year to discuss issues affecting community colleges and make recommendations to the Board of Directors**
